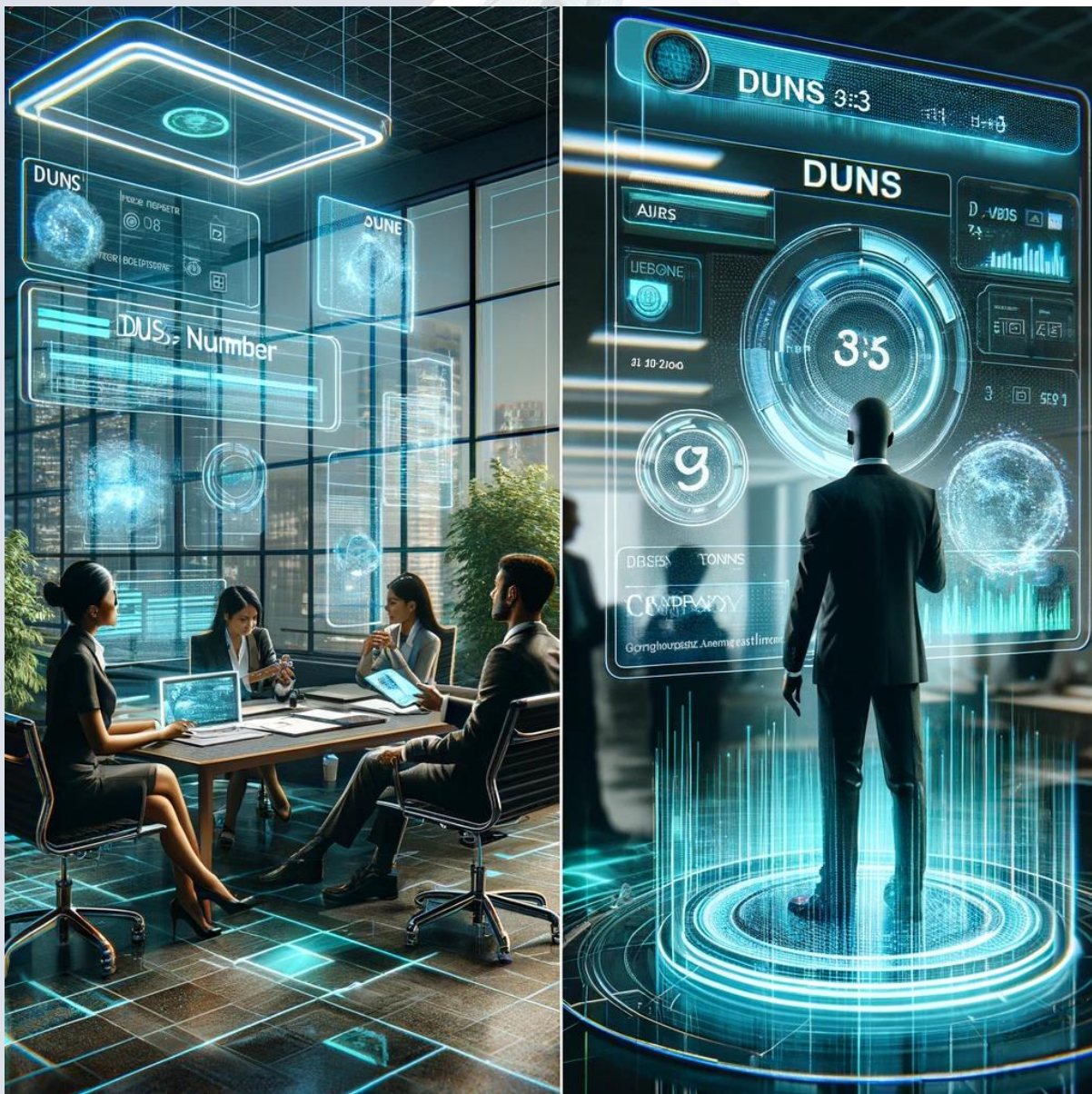


## Get DUNS number / (DUNS) number

A company registered outside the United States needs to obtain a Data Universal Numbering System (DUNS) number to enter into a contract with the US government or receive a grant.



### How do I get my DUNS number?

## What information do I need to provide to get a DUNS?

To obtain a DUNS, you will need the following information

- company name;
- legal and actual address of location;
- information about the owner of the company;
- form of organization (corporation, partnership);
- date of establishment of the company;
- type of activity;
- number of employees.

## How long does it take to register?

## Peculiarities of registration for foreign companies

Companies located outside the United States of America are registered in the Dun & Bradstreet database. In order to cooperate with the US federal government and meet IRS tax reporting requirements, you must additionally obtain a TIN (Employer Identification Number).

### What is a DUNS number for?

Registration of a unique identifier is necessary for:

- Applying for government contracts. The US federal government requires contractors and applicants for government grants to have a DUNS.
- Addressing potential partners. A representative of any company or an individual can view the company's DUNS rating. For many companies, this is a popular solution that allows them to verify the financial stability and reliability of a legal entity.
- Application development. Apple requires iOS developers to use a unique identifier when creating an account in the App Store. This is mainly to standardize the process and to submit applications
- Supplier registration. Many retailers require a supplier to have a DUNS number, as it makes it easier to find standardized information about the partner.
- Applying for an SSL certificate. The number is an optional requirement, but it speeds up the process by quickly providing reliable information. Obtaining an SSL certificate allows companies to make their websites more secure
- Obtaining a business loan. You will be able to build a credit history and strengthen confidence in your business.
- Tracking credit reports. By using the code, you get access to updated information about your company in the database and can correct any errors in the reports.
- Obtaining financing. A positive credit rating allows you to apply for loans, credits, and other types of financing.

### What is a DUNS number and why is it needed?

The DUNS number is primarily used to conclude contracts with the US government and to be able to provide indisputable evidence of your impeccable reputation to international partners



### **How long will it take to get a number?**

The process usually takes 7 to 30 business days. BUT in 80% of cases, we manage to register the number within 1 to 3 business days! We have been helping to register DUNS numbers for 11 years, so all the processes are perfectly established.

### **What documents do I need to obtain a DUNS number?**

We start with the company's statutory documents (depending on the country of residence, they will vary, but we will tell you what exactly you need in your case), the name and contact details of the owner.
