Designse LLC in Ukraine: preparation of documentation

The list of securities may depend on who the founder of the new company is. Founders (residents) individuals prepare a copy of their passport and identification code.

Non-residents prepare a copy of their passport and identification code (if available).

Founders of legal entities (residents) need to prepare only the EDRPOU code, as well as the name. The remaining documents will be prepared by our company employees.

Companies registered abroad require the following documents:

- 1. A notarized copy of the paper that confirms the registration of a legal entity in the state.**
- 2. A document confirming the authority of the manager, founder or other person representing the interests of a foreign company.**
- 3. Protocol of the highest body of a legal entity that it has decided to become the founder of a registered company.**

You also need to have a copy of your passport and manager's identification code.

What is needed to register a turnkey company?

The founder must provide a minimum amount of data:

- **company name;**
- **company location;**
- **phone number;**
- **the amount of the authorized capital (if it was formed at the expense of property, a special list is drawn up);**
- **distribution of parts of the authorized capital (interest of each founder);**
- **the main type of activity of the company;**
- **name of the executive body;**
- **presence of a chief accountant at the company (this is not always required);**
- **tax system type.**

The entire procedure is aimed at entering the company into the Unified State Register, so that your activities function legally, you receive income, and transfer money to government agencies. By contacting us, you will promptly receive all the necessary documentation.

How is LLC registration done?
